I. Philosophy

Mission Statement -St. Joseph Catholic School

St. Joseph Catholic School is a faith-filled, family atmosphere parish school serving preschool through eighth grade that inspires families to lead, learn and serve through the Catholic faith.

II. Catholic Dimension/Uniqueness

Catholic Atmosphere

Religious education at St. Joseph Catholic School occurs in two major areas: the study of the Catholic faith and integrating faith experiences into the life of each student.

Besides classroom instruction in religion, liturgical and sacramental participation is part of our school program. Celebration of the Sacrament of Reconciliation, all school liturgies, and opportunity to participate in Mass are part of the spiritual life of the school.

Parents/guardians are encouraged to become aware of and encourage their child(ren) in his/her faith life. The school can only support what is taught and experienced at home.

Prayers, Practices, and Beliefs

A list of prayers and other basic beliefs and practices for students has been developed. Prayers may be introduced at one level and students may not be expected to have them memorized until the next year. However, students are expected to have an understanding of these prayers and they will be a part of our prayer at school. We encourage you to also pray with your child at home.

Spiritual Program

The spiritual program of the school recognizes that "to provide a sound academic program which includes emphasis on Catholic teachings within the atmosphere of Christian living" cannot be gained in the formal classroom only. The formal classroom learning is the beginning.

Every Christian has the responsibility to use one's gifts for the good of the community and to minister as Jesus did. This is the core of the Christian life.

Parents/guardians are always invited to the school liturgies. This schedule is published in the SJW and can be viewed online at www.sjcsmarion.org

- Sacramental Preparation Preparation for the first reception of the sacraments of Reconciliation and Holy Eucharist will be given in second grade. Parents/guardians should be directly involved in the religious education of their children. Meetings are held to inform and assist parents/guardians in the sacramental preparation for their child.
- Liturgical Celebration Students and teachers plan and participate in weekly liturgies. Parents/guardians are always welcome to attend.

III. Admission Policies/Notice of Non-Discrimination

Admission

Children who are five years of age by September 15 are eligible to enroll for entrance into kindergarten. Children who are six years of age by September 15 are eligible to enroll for entrance into the first grade. Exceptions to this policy are not allowed. (AFFC/ACSB Policy 5112)

A copy of your child's **birth certificate** is needed for our records prior to the beginning of school. **This is a State of Iowa law.** We are required by the State of Iowa to have an **immunization record** on file for each child enrolled. This must be the <u>Iowa immunization card</u>. This form must be on file before your child begins school. It must be dated and signed by a doctor or registered nurse. **Your child cannot be admitted on the first day of school without this completed card on file.** A copy of your child's **Baptismal certificate** is needed for our records at the beginning of school. This gives you ample time to secure the certificate if your child was baptized

somewhere other than St. Joseph Church. If your child was baptized at St. Joseph Church, we still need the exact date prior to the beginning of school.

Children are charged tuition. St. Joseph Catholic School will accept students of any religious conviction. However, as a student, everyone is considered a part of the total school community and will be included and expected to participate in all activities scheduled as part of the class day, and all required classes even those of a religious nature.

Equal Opportunity

St. Joseph Catholic School is an equal opportunity employer and school. No student will be discriminated against because of his or her race, creed, color, sex, sexual orientation, gender identity, national origin, religion, socioeconomic status, marital status, or disability. However, students are required to meet the school's academic and financial requirement(s). As a bona fide religious institution, educational programs governed by the Archdiocesan Catholic School Board may consider a student's religion, sexual orientation and/or gender identity a qualification for enrollment when such qualifications are related to a bona fide religious purpose.

IV. Academic Policies/Programs

Academic Eligibility Policy for Extra-Curricular Activities

The St. Joseph Catholic School vision is to be a Catholic School of Excellence. To fulfill this goal of high standards in academic achievement, it is important that we hold academic progress in the very highest regard and demand that academic excellence from our students.

Students at St. Joseph Catholic School must complete satisfactory course work as a pre-requisite for participation in all extra-curricular/co-curricular activities. The following rules will apply to those students in grades 6-8 who are participating in extra-curricular/co-curricular activities. (Extra-curricular/co-curricular activities include those activities which are not graded.)

Deficiency Period

Grade 6-8

If a student has one "one" marking in any academic class during a grading period and/or 3 "one" markings in citizenship, they are ineligible until the next grading period. Parents/Guardians will be notified via Principal or designee of this status. (A grading period includes grades submitted on the 1st and 15th of each month.)

Students that are "ineligible" based on the criteria at the end of grading period will still be able to attend practices, but will not be permitted to dress for games/performances/non-graded activities.

Students who have special learning accommodations (under Section 504) will not be exempt from this rule. It is the belief of St. Joseph Catholic School that students utilizing Section 504 should be able to satisfactorily complete the required coursework with the appropriate accommodations.

Administrative Regulations

- Grade and citizenship reports will be run at noon on the 1st and 15th of each month.
- Teachers must post grades in the grade book within a reasonable timeframe.
- Grades will be run based on the current Quarter of the academic year, not Semester. The Principal or designee will, at that time, inform students of their eligibility status and contact the student's parents/guardians. It will

also be the responsibility of the Principal to contact the moderator/coach/athletic director to inform them of the student's status.

<u>Assessment</u>

Each year students in grades 3—8 take the Iowa Statewide Assessment of Student Progress. When test results have been returned and analyzed, parents/guardians will receive appropriate information. In addition, personal conferences are available with parents to go over the results in more detail. Parents are encouraged to set up appointments if they wish more information.

Copyright

It is the policy of the educational programs governed by the Archdiocesan Catholic School Board (AFFC/ACSB #2510) that all employees, volunteers, and students will abide by the federal copyright laws. Employees, volunteers, and students may copy print or non-print materials allowed by:

- 1.copyright law
- 2.fair use guidelines
- 3.specific licenses or contractual agreements
- 4.other types of permission

Employees, volunteers, and students who willfully disregard copyright law are in violation of Archdiocesan policy, and are doing so at their own risk and assuming all liability.

Field Trips

Field trips aid the instructional program by enabling the children to experience educational resources not found in the classroom. All students are expected to observe school policies when they are on field trips. Students are also expected to provide a signed permission slip from their parents/guardians.

Students will leave school, remain, and return together with their assigned group and chaperone. They may not be excused to leave the group during the trip.

Students who have driver's permits may not drive any field trip vehicle.

Students age 5 and under must be provided proper restraints in the form of a booster or car seat in accordance with Iowa Law. Please do not volunteer to chaperone on field trips if you have other children (who are not members of the class) that need to be supervised (liability insurance coverage/alters student: chaperone ratio).

Homework

Homework is encouraged in order to teach students the importance of practice, review, and application. Teachers will try to assign homework in accord with the age of students. Parents/guardians should not have to instruct students but are encouraged to support the process through questions and suggestions when appropriate.

Human Sexuality Program

Human sexuality instruction is integrated into the Religion program and is presented from the Catholic perspective in the context of total growth. Parental/guardian support and involvement is an essential component of this program. Information will be sent to parents/guardians as the time for this program approaches. An option is provided for students whose parents/guardians do not want them to participate in these classes. A request for exemption must be in writing to the principal. Parents are permitted to review the course materials at any time. Please refer to AFFC/ACSB policy #6141.11 for specific details.

Internet

It is the policy of educational programs governed by the Archdiocesan Catholic School Board to require the ethical use of the Internet and related technologies by all employees, volunteers and students. (AFFC/ACSB Parent/Guardian-Student Handbook Page 7

#2511,AFFC/ACSB #5144.3) Access privileges may be revoked, school disciplinary action may be taken, and/or appropriate legal action taken for any violations that are unethical and may constitute a criminal offense.

Instrumental Music

Instrumental Music is offered to all 4th through 8th grade students. An individual lesson or small group is given approximately once a week. Instrumental Music is a class and therefore requires a semester commitment. Permission to be excused from Concert Band must be approved by the Band Director. Concerts are required as part of the Instrumental Music class. Extracurricular music ensembles are listed under activities.

Vocal Music

All students wishing to participate in Middle School Show Choir must also be part of the St. Joseph Catholic School 6th-8th grade Choir.

Multi-Cultural/Gender Fair/Global Education

St. Joseph Catholic School offers a global, multi-cultural, gender fair approach to the educational program.

St. Joseph Catholic School is committed "to a curriculum that fosters respect and appreciation for cultural and racial diversity and an awareness of the rights, duties, and responsibilities of each individual as a member of a multicultural, gender fair society." (AFFC/ACSB #6144.2) The education program is one of permeation and action for the implementation of the global, multicultural, and gender fair elements of the students' education.

Physical Education Waiver

A pupil shall not be required to enroll in either physical education or health courses if the pupil's parent or guardian files a written statement with the school principal that the course conflicts with the pupil's religious beliefs. (AFFC/ACSB #6144.3)

School Parties

Parties which consume valuable school time are discouraged. However, students may bring birthday treats. If a student should wish to do this, the treats will be passed and shared.

After school parties are the responsibility of parents/guardians. Late evening parties are discouraged during the school week.

Please do not send your child to school with invitations to a party where all students are not invited. Teachers will not, under any circumstances, send invitations home. It can be a painful time for students when not invited.

School Day

School begins at 7:45 a.m. and is dismissed at 2:40 p.m. All doors will be locked at 7:45 A.M. All visitors must come to the school office and sign in. Visitors must wear a visitor's badge at all times.

Student Arrival & Departure Procedures

As a result of the Archdiocesan Program and focus on "Protecting God's Children", St. Joseph School has put in place the following arrival and departure policy and procedures:

Morning Arrival

Students are not to arrive prior to 7:30 a.m.

At 7:30 a.m. students will be permitted to enter the building and are to proceed directly to the gym, where there will be a teacher on duty.

Students will walk in the gym until 7:45 a.m.

At 7:45 a.m. students will have morning announcements and proceed to their classrooms when announcements have been finished.

Late Arrival

A child is deemed to be late if he/she arrives after 7:45 a.m. A parent/guardian is required to accompany his/her student to the school office to sign student in. Student will receive an Admit Slip and will proceed to class and present the Admit Slip to the teacher.

Afternoon Dismissal

Students will be released to parent/guardian or only to individuals identified on their emergency contact form. If student is to be released to someone other than the individual listed on their emergency contact form, a note signed by parent/guardian must be sent to the student's homeroom teacher in the morning on the day that the change in release will occur. In case of an emergency, please call the office to make appropriate arrangements.

The end of the day is extremely busy and the office receives many last minute changes for students. It is difficult to track everyone down and it interrupts instructional time. Please make last minute changes for emergencies only, or call before 2:00 p.m. If your child is leaving early, a note or phone call needs to be sent to the office documenting why they are leaving early.

Students not picked up by 3:00 p.m. will be sent to After School Care. This includes all students K-8.

Parents/guardians will be charged a few for After School Care.

Special Services

The service of a psychologist, social worker, speech therapist and diagnostic testing for learning disabilities are available through AEA 10. Requests for these services are made by parents/guardians, or by teachers in agreement with parents/guardians and the school principal. All parental rights are strictly maintained.

When your child has been referred for special education services, federal and state laws give you certain rights. Some of these are:

- 1. The right to be contacted and told what the school plans to do about your child's educational program. This must be done before your child is tested or placed in a program.
- 2. You have the right to consent. This means the school must have your permission prior to placing your child in a special education program.
- 3. The right to a full evaluation of your child's needs. If you don't agree with the school's findings you may request an outside evaluation.
 - 4. The right to see your child's records kept at school.
- 5. The right to privacy of information. With a few exceptions, no one may see your child's record without your permission, given in writing. Exceptions are people such as your child's teacher, or other school officials engaged in planning your child's educational program.
- 6. The right, as much as possible, to have your child in classes with children who are not in special education programs.
 - 7. The right to be involved in the development of your child's IEP (individual education program).
- 8. The right to have someone present to help you in the development of your child's IEP. This could be another parent, a teacher, a lawyer, or an advocate.
- 9. The right to appeal decisions made by the school regarding your child's diagnosis or placement.

If you desire additional information, please contact your child's principal.

Student Assemblies-School Liturgies

All school assemblies and liturgies are part of our school program. When any person is before the assembly to address the group, there is to be no talking among students or improper behavior: shouting, whistling, excessive noise, whispering are discourteous acts.

Substance Abuse Education

A substance education program is one component of the guidance program. It includes basic student education reinforcing activities/events, family education (through parent/guardian meetings), and utilization of appropriate community agencies. The Marion Police Department also sponsors the DARE program for grade 5 in our school. Officers from the police department are the instructors for this curriculum.

V. Communication

Absence

Regular attendance is a key factor in the success of school work. The value of the work missed is difficult to make up by out-of-class work.

Parents/guardians are requested to phone the school by 8:45 a.m. (or leave a message on the messaging/attendance center (prior to 8:45 a.m.) if a child will be absent and inform the school of the reason for the absence. If a student will be absent for an extended time due to illness, parents/ guardians should inform the principal/school. When a child returns to school, a note explaining the child's absence must accompany the child unless the parent/guardian contacted the office via phone previously.

Doctor/dentist appointments are best made after school hours or on free days. A student who must, as an exception, be excused for an appointment should have a written notification for the teacher. A written request from the parent/guardian or a phone call is also required anytime a pupil needs to leave school before the usual time of dismissal. No child is released unless the principal or his/her designee knows the reason for the release and the person to whom the child is released. A parent/guardian must come to the school office and sign the student out. If the student returns after the appointment, the parent/guardian must accompany the student to the school office and sign the student back into school. The school accepts no responsibility for any child who leaves without the proper permission.

The principal/secretary approves the dismissal of pupils who are ill. Parents or guardians are notified when an illness is detected and are to make arrangements to pick up their child in a timely manner. When records indicate there is a concern regarding frequent tardiness or absence, the archdiocesan compulsory attendance procedures will be followed.

Dual Parent Reporting- Divorced/Separated Parents

According to AFFC/ACSB 5124, in the case of a student's whose parents' marriage has been dissolved or a separation of a parent from the home, the name and address of both parents should be on file.

Unless otherwise decreed by a court order, information commonly made available to parents of any student in attendance at St. Joseph Catholic School (i.e. notices of school functions, progress reports, newsletters etc.) will be made available to both parents.

Communication Methods

- Parent/School Communications Adequate and clear communication between school and home is essential for the success of the children. Parents/guardians should feel free to call teachers about student progress or other situations of concern. The best time to talk to your child's teacher is after school hours.
- A parent newsletter will be sent electronically. In cases where electronic media is not an option, a hard copy will be sent home with the youngest child.
- Publications/Parent Notes Any publications/parent notes may not be distributed through the school office or through teacher or classroom without the approval of the principal. Any note from individuals not employed by the school must be approved and initialed by the principal.
- Parent-Student-Teacher Conferences Conferences are held after the first and third quarters. Others can be scheduled by either parents/guardians or teachers as the need is recognized.
- Progress Reporting The purpose of progress reporting is to communicate the individual student's learning growth. Effective communication is best established through parent-teacher conferences, appropriate phone calls/notes, and quality progress reporting. Such communications necessarily focus on the individual learner in order to determine the performance level in terms of the student's ability and background.

Because growth occurs best in a positive learning environment which enables success experiences for the student, progress in learning is reported and indicated in positive ways. Just as our learning programs are outcome/standard-oriented with defined benchmarks, so too, reporting to parents/guardians needs to be in accord with those outcomes/standards and in keeping with the students' abilities and needs. In such a way, reporting reflects evaluation of the individual's total growth in terms of potential and self-competition instead of competition against peers who differ in abilities and needs.

Early Dismissals, School Closings, and Late Start Procedures

St. Joseph Catholic School typically follows the **Marion Independent School District regarding school closings and late starts-bad weather, but we will make our own call.** Please do not call the school. Listen to the local TV channels for official announcements. Closings, late starts, etc. are sent through text messages and e-mail.

Linn-Mar bus students have an excused tardy if they arrive late because of weather. (Linn-Mar has several routes in the country and cannot always run their buses on time because of weather conditions.) Likewise, Linn-Mar bus students will have an excused absence if they cannot arrive at school because of weather.

Student Privacy Act

In conformity with the Student Privacy Act, and AFFC/ACSB 5125, St. Joseph Catholic School does not send out student/graduate information to any outside organizations without written authorization of the student/graduate.

Student Records

A permanent record of each pupil is kept on file at school in accord with AFFC/ACSB 5125. These records are private property and are submitted only when lawfully requested. Should parents/guardians wish to see the records of their child, they should contact the principal.

<u>Telephones</u>

Students are expected to have the permission of the principal/teacher to use the school telephone before, during or after school. Cell phones should not be used during the day by students without teacher permission.

The school phone is intended for calls concerning school business. Calling home for forgotten items is discouraged. Also, except for an emergency, neither teacher nor student is called to the phone during school hours. The phone is not intended for general use of students. After school arrangements should be made before the child leaves for school.

When it is necessary for a student to use the phone, permission must be obtained from his/her teacher. Students must have a pass from his/her teacher and/or permission from the principal/secretary to use the phone during and after school.

Watches

Smart watches can only be worn to check the time and will be taken away if used for other reasons such as connecting to your phone. Disciplinary action regarding smart watches is the same as cell phones.

Visiting Classes

Please contact the school principal to arrange a time. All visitors must come to the school office and sign in. Visitors must wear a visitor's badge at all times.

VI. Discipline Code

In order to provide and maintain an atmosphere which permits the orderly and efficient operation of the school and which encourages learning and helps students to develop a Christian code of personal conduct, school rules and regulations are in effect. These policies and procedures have been established by the St. Joseph Catholic Board of Education and administration after consultation with faculty, parents and students. Their effectiveness requires the positive and voluntary cooperation and support of all concerned.

The knowledge of the rules and regulations, their processes, and their implementation are the responsibility and obligation of each St. Joseph Catholic student. Neither ignorance or lack of understanding of the rules and regulations will release a student nor parent/guardian from responsibility to cooperate with the stated polices. All Archdiocesan policies and State of Iowa education laws, as they apply to St. Joseph Catholic School, are to be respected and followed.

Discipline Code

It is the personal responsibility of each student to behave in a manner that is appropriate for the educational setting and reflective of the rights of other students and teachers. Most students do not use rules and consequences to form their behavior. They simply use common sense and do what they know is right.

Good conduct is based on the premise of "Living the Gospel" by respecting self, others, and environment. Students will be expected to conduct themselves in such a way that the rights of others are not violated. The students of St. Joseph Catholic School will conform to school regulations and accept directions from authorized school personnel.

A student who fails to comply with established school rules or with any reasonable request made by school personnel on school property and/or at school related events will be dealt with according to approved student discipline regulations.

The Code of Conduct and continuum of consequences for St. Joseph Catholic School is broken down into 3 levels of misconduct with the Positive Behavior Supports program that is implemented throughout the school. We realize that the majority of students adhere to the Code of Conduct on a daily basis, but it is important to have procedures outlined that enable us to provide a safe and orderly school environment with a fair and consistent approach to discipline. To that end, you will see a list of rules that fall into specific categories of misconduct.

St. Joseph Catholic School teachers and staff are empowered to administer disciplinary consequences for Level 1 infractions. However, we ask that for each disciplinary consequence given by a teacher, a written referral (non-office ODR) be completed and that parents/guardians are contacted.

Disciplinary consequences resulting from acts of misconduct that place students on Levels 2 or 3 will be handled by the administration. These students will be sent to the office with a completed referral ODR (Office Discipline Referral). The administration and/or teacher will contact the parents/guardians and inform them of the situation and the disciplinary consequence assigned.

It is our goal to dispense fair and consistent disciplinary consequences for inappropriate behavior that will help ensure an environment that is conducive to academic achievement. Also, it is important to remember that the Positive Behavior Supports program focuses not only on prevention through disciplinary consequences, but intervention to help build a skill set that will enable our students to grow and make better choices in the future. It is important that we not only monitor student behavior, but that we help manage behavior by offering support and guidance for our students.

Middle School (6th-8th grades)

• Level 1:

A Level 1 will be given if a student receives a "1, 2, 3" in one class period. A Level 1 may also be given for any of the "Level 1 Acts of Misconduct" listed below. A Level 1 consequence will accompany any Level 1 violation. The teacher will complete a Discipline Report and contact a parent/guardian. A parent must sign and return the Discipline Report to school on the next school day.

• Level 2:

A Level 2 will be given for any of the "Level 2 Acts of Misconduct" listed below. A Level 2 will also be given on the third and subsequent Level 1 violation (each semester). A Level 2 consequence will accompany any Level 2 violation. The teacher will complete a Discipline Report, the student will be referred to the principal, and the teacher and/or principal will contact a parent/guardian. A parent must sign and return the Discipline Report to school on the next school day.

• Level 3:

Level 3 violations are extremely severe in nature. Please refer to the information below on these violations and consequences.

3rd-5th grades

• Level 1:

A Level 1 will be given if a student receives a "1, 2, 3" in one half day (morning/afternoon). A Level 1 may also be given for any of the "Level 1 Acts of Misconduct" listed below. A Level 1 consequence will accompany any Level 1 violation. The teacher will complete a Discipline Report and contact a parent/guardian. A parent must sign and return the Discipline Report to school on the next school day.

• Level 2:

A Level 2 will be given for any of the "Level 2 Acts of Misconduct" listed below. A Level 2 will also be given on the third and subsequent Level 1 violation (each semester). A Level 2 consequence will accompany any Level 2 violation. The teacher will complete a Discipline Report, the student will be referred to the principal, and the teacher and/or principal will contact a parent/guardian. A parent must sign and return the Discipline Report to school on the next school day.

• Level 3:

Level 3 violations are extremely severe in nature. Please refer to the information below on these violations and consequences.

Code of Conduct – Disciplinary Consequences

The following disciplinary consequences are generally used in handling behavior problems. When serious violations occur, steps within this sequence may be skipped. All consequences are carried out in accordance with ABE 5144.1.

A student/parent/teacher meeting may occur in conjunction with any Level 1, 2, or 3 violation. The principal will be involved in these meeting as appropriate.

The St. Joseph Catholic School 1:1 Acceptable Use Policy and K-8 Acceptable Use Policy gives guidance for students on electronic devices.

Level 1 Consequences

- 1. **Time Out** If students violate any rule or regulation, they may be removed from the class for a finite period of time. Teachers are authorized to utilize time out.
- 2. Loss of Privilege If students violate any rule or regulation, they may be subject to a loss of privilege. Loss of privilege may include eating lunch in isolation, loss of recess, or loss of free time. Teachers are authorized to utilize loss of privilege.
- **3. Detention** If students violate any rule or regulation, they may be assigned to detention for 30 minutes after school. Detentions are assigned for Monday, Tuesday, and Thursday. Detention must be served within one week. Failure to serve the assigned detention will result in one day in school suspension. Teachers are authorized to utilize detention.

Level 2 and 3 Consequences

- **4.** Loss of Eligibility (or Privilege at the 3rd-5th grade level) If students violate any rule or regulation, they may be subject to a loss of eligibility for all co/extra-curricular activities. Administrators are authorized to utilize loss of eligibility.
- **5. In-School Suspension** If students violate any rule or regulation, they may be assigned and In-School Suspension from 7:45 AM until 2:40 PM. Administrators are authorized to utilize In-School Suspension.
- **6. Out of School Suspension** If students violate any rule or regulation, they may be assigned an Out of School Suspension. Suspensions are reserved for more serious infractions or chronic misbehavior. Administrators are authorized to utilize Out of School Suspension.
- 7. Expulsion Reserved for the most serious forms of misbehavior or chronic misbehavior. The Board of Education is authorized to utilize Expulsion at the recommendation of the Administration in accordance with ABE 5144.1.

Level 1 Acts of Misconduct

- 1. Chronic misbehavior, which results or interferes with any school activity.
- 2. Disregard of reasonable directions or commands by school authorities including school administrators and teachers.
- 3. Harassment or abuse of another. No student shall in spoken or written form use or direct words, phrases, or actions which are considered to be slanderous, degrading or threatening in nature, and/or words or phrases which are obscene or profane as defined by the majority of our society. Name-calling and negative, uncomplimentary and offensive remarks related to physical handicaps or defects, mental handicaps, race, religion, nationality, appearance or other reason is prohibited.
- **4.** Disrespect to a teacher or other school authority.
- 5. Refusing to take (or skipping) detention or other properly administered discipline.
- **6.** Forgery of school or school related documents.
- 7. Cheating or plagiarizing.
- **8.** Gum chewing, beverages (excludes water bottles), candy and food are not permitted in classrooms, study halls, library, hallways, bathrooms, or on the playground during recess.
- 9. Gambling.
- 10. Students shall not be permitted to possess electronic laser pointing devices or electronic light emitting devices without written permission from the administration.
- 11. Cursing or use of indecent or obscene language or obscene gestures in oral or written form.
- 12. Publication of obscene, pornographic or libelous material.
- 13. Placing signs or slogans on school property without the permission of the proper school authority.
- **14.** Distribution on school premises of pamphlets, leaflets, buttons, insignia, etc., without the permission of proper school authority.
- 15. Demonstrations by individuals or groups causing disruption to the school program.
- 16. Tardiness.
- 17. Presence in areas during school hours or outside school hours where a student has no legitimate business without permission of proper school authority.
- 18. Failure to abide by the dress code.
- 19. Any disruption or interference with school activities.
- 20. Willfully aiding another person to violate school regulations.
- 21. Any other activity by a pupil, which the pupil knows or should know, will disrupt the academic process of a curricular or extracurricular activity.
- 22. Violation of any Board of Education rule, regulation, or policy.
- 23. A student who carries a cellular phone, IPOD or any other MP3 player must keep the device turned off during the day and in the student's locker. A student may place a call on a cellular phone with permission of a teacher

or administrator. Misuse of an electronic communication device during the school day may result in confiscation of that device by a staff member or administrator.

24. Failure to follow the St. Joseph Catholic School Acceptable Use Policies (AUP).

Level 1 instances of misconduct should be recorded utilizing the behavior management software. In most case, these instances of misconduct will not require ODR notification.

Disciplinary Consequences appropriate for Level One Acts of Misconduct:

- Time Out
- Loss of privilege
- Detention (In the case of K-2, students may be referred to the office in lieu of detention. Parents/guardians will be notified if a student is referred to the office.)

Any student with three Level One Acts of Misconduct can be referred to the office utilizing the ODR. At this point, the behavior may be treated as a Level Two Act of Misconduct and appropriate disciplinary consequences may be applied.

The administration will make the final decision to determine if the consequence should be upheld or moved to a higher level of disciplinary consequences.

Level 2 – Acts of Misconduct

- **25.** Damage or destruction of school property, property of school employees, or property of other students on or off school premises.
- 26. Damage or destruction of private property on school premises or in areas controlled by the school.
- 27. Harassment of school personnel or other students during school and/or non-school hours.
- 28. Fighting.
- 29. Hazing (to persecute or harass or humiliate another student and/or employee).
- **30.** Falsifying of information given to school authorities in the legitimate pursuit of their jobs.
- **31.** Extortion of a student or school personnel.
- **32.** Theft or possession of stolen goods.
- 33. Possession of matches or lighters or other similar devices.
- **34.** Buying, selling, transferring, using or possessing any substance containing tobacco, including, but not limited to, cigarettes, cigars, a pipe, clove cigarette, chewing tobacco, snuff, and dip, or using tobacco in any other form.
- 35. Leaving school during school hours without permission of the proper school authority.
- **36.** Upon initial arrival, leaving school property without permission.
- **37.** Failing to report the actions or plans of another person to a teacher or administrator where these actions or plans of another person, if carried out, could result in harm to another person or persons or damage property, when the student has information about such actions or plans.
- 38. Truancy.
- 39. Failure to follow the St. Joseph Catholic School Acceptable Use Policies (AUP).

Level 2 instances of misconduct should be recorded utilizing the behavior management software. In most cases, these instances will require ODR notification.

The administration will make the final decision to determine if the consequence should be upheld or moved to a higher level of disciplinary consequences.

Disciplinary Consequences:

- Loss of Eligibility (or Privilege at the 3rd-5th grade level)
- In School or Out of School Suspension (1-5 days)

Level 3 – Acts of Misconduct

- **40.** Assault on a school employee, student or other person.
- **41.** Possession or use of dangerous or ordnance or objects which look like weapons or ordnance, including but not limited to, guns, firearms, ammunition, knives, grenades, sling shots, bows, arrows, machetes, brass knuckles, chains, studs, etc.; or possession or use of objects which may render physical harm to another if improperly used, including but not limited to, hatchets, hammers, ice picks, screwdrivers, knives, etc.
- **42.** Buying, selling, transferring, using, possessing, or being under the influence of any controlled substance (drugs, narcotics, marijuana, etc.) or inhalants, or buying, selling, using, or possessing or being under the influence of any counterfeit controlled substance, (any substance that is made to look like a controlled substance, or is represented to be a controlled substance, or that is believed to be a controlled substance).
- **43.** Buying, selling, or transferring, using, possessing, or being under the influence of any drug, medication, inhalant or other controlled substance which can be taken internally where the students involved cannot show a legitimate health or other reason for the use of such substances.
- **44.** Buying, selling, or transferring, using, or possessing any drug or alcoholic paraphernalia to include instruments, objects, papers, pipes, containers, etc.
- **45.** Buying, selling, or transferring, using, possessing or being under the influence of any alcoholic beverage or intoxicant of any kind.
- **46.** Indecent exposure.
- 47. Engaging in sexual acts, displaying excessive affection or other inappropriate behavior.
- **48.** Turning in a false fire, tornado, bomb, disaster or other alarms, or any other activity, which includes panic defined as:
 - a. Initiating or circulating a report or warning of an alleged or impending fire, explosion, crime, or other catastrophe, knowing that such a report is false.
 - b. Threatening to commit an "offense of violence".
 - c. Committing any offense with reckless disregard of the likelihood that its commission will cause serious public inconvenience or alarm.
- **49.** Convey, attempt to convey or knowingly possess a deadly weapon or dangerous ordnance onto any property owned or controlled by or to any activity held under the auspices of the Board of Education.
- **50.** Sell, offer to sell, or possess a controlled substance on school premises or at a school related function (trafficking in drugs).
- 51. Commission by a pupil of any crime in violation of the Iowa Criminal Code or the Iowa Juvenile Court.
- **52.** Arson or the improper use of fire, or handling or discharging a fire extinguisher at any time other than an emergency (\$50 fine for the illegal discharge of a fire extinguisher).

Level 3 instances of misconduct should be recorded utilizing the behavior management software. In all cases, these instances will require ODR notification.

The administration will make the final decision to determine if the consequence should be upheld or moved to a higher level of disciplinary consequences.

Disciplinary Consequences:

- 3-10 day suspension with possible recommendation for expulsion.
- Ten days out of school suspension with a recommendation for expulsion.

Fire Extinguishers

Any student handling or discharging a fire extinguisher at any time other than in an emergency will be fined \$50.00.

<u>Gangs</u>

In accord with AFFC/ACSB 5133, if a student is suspected or identified as being a member of a gang, initiates or participates in any gang related activity, or is actively involved in recruitment for a gang, any or all of the following steps may be taken:

- 1. Parents/guardians will be contacted immediately and appropriate intervention initiated.
- 2.A behavior contract will be prepared stating the conditions for the student remaining in the school.
- 3.Students may be referred to counseling (personal and/or family).
- 4.Students may be referred to the Department of Human Services or other welfare or childcare agencies of the respective county.
- 5.Students may be referred to outside agencies or programs for treatment when use of drugs and/or alcohol is involved.
- 6.Students may be referred to the Task Force on Violent Crime (if applicable).
- 7. Police, Juvenile Court, and other appropriate authorities will be notified of violence and/or illegal activities.
- 8.Students may be suspended and/or expelled as outlined in the school/program/Archdiocesan discipline policies.
- 9.Parents/students will be held liable and financially responsible for all forms of vandalism.

Bullying/Harassment

It is the policy of the Archdiocesan Catholic School Board and St. Joseph Catholic School to maintain a learning environment that is free from any type of harassment/bullying. No student associated with the educational programs governed by the Archdiocesan Catholic School Board shall be subjected to any type of harassment/bullying while on school/parish property, at any school/parish function, or at a school/parish sponsored activity regardless of location.

It is a violation of policy for any school employee, volunteer or student to harass/bully a student through conduct or communications as defined below.

"Harassment" and "bullying" shall be construed to mean any electronic, written, verbal, or physical act or conduct toward a student which is based on any actual or perceived trait or characteristic of the student and which creates an objectively hostile school environment that meets one or more of the following conditions: 1) places the student in reasonable fear of harm to the student's person or property, 2) has a substantially detrimental effect on the student's physical or mental health, 3) has the effect of substantially interfering with a student's academic performance, 4) has the effect of substantially interfering with the student's ability to participate in or benefit from the services, activities, or privileges provided by the educational program. It includes but is not limited to 1) epithets, slurs, negative stereotyping, or threatening, intimidating, or hostile acts; 2) written or graphic material that denigrates or shows hostility or aversion toward an individual or group that is circulated within or placed on walls, bulletin boards, or elsewhere on premises where the educational program operates; and 3) name-calling, sarcasm, spreading rumors, excessive teasing and hazing.

"Trait or characteristic of the student" includes but is not limited to age, color, creed, national origin, race, religion, marital status, sex, sexual orientation, gender identity, physical attributes, physical or mental ability or disability, ancestry, political party preference, political belief, socioeconomic status or familial status.

"Electronic" means any communication involving the transmission of information by wire, radio, optical cable, electromagnetic, or other similar means. "Electronic" includes but is not limited to communication via electronic mail, internet-based communications, pager service, cell phones, and electronic text messaging.

The standard for determining whether verbal or physical conduct is sufficiently severe or pervasive to create a hostile or abusive environment is whether a reasonable student in the same or similar circumstances would find

the conduct intimidating, hostile or abusive. It is not necessary to show that the victim was psychologically harmed.

Any school employee, volunteer, parent, guardian or student who witnesses or becomes aware of conduct in violation of this policy should file a complaint in writing directly to the victim's or perpetrator's teacher, immediate supervisor, principal, or the Superintendent of Schools of the Archdiocese of Dubuque. The complaint shall describe the perceived violation, name the perpetrator and the victim, and identify any potential witnesses to the incident.

This policy is in compliance with Iowa Code Chapter 216 and 280.12(2)(f) and AFFC/ACSB policies 2515.1, 2515.11, 5144.3.

School Dress Code – see Page 45

Search and Seizure

It is the policy of St. Joseph Catholic School Board of Education to operate its educational programs in a Catholic, orderly environment. Recognizing that the presence of contraband on school property or on the person of a student attending school is not consistent with the above policy, St. Joseph Catholic School adopts the policy as stated in AFFC/ACSB 5145.2 which refers to the rules relating to periodic inspection, to the search of students and/or to protected student areas.

Contraband includes substances or items which, if found on school property, violate the law and school regulations, or are detrimental to an orderly environment at school. Contraband includes by way of illustration, but is not limited to, drugs, narcotics, tobacco, liquor, weapons and stolen property. It consists of substances or items which may cause a substantial disruption of the school environment, and/or which present a threat to the health and safety of the students and staff.

Tobacco, Drinking, Use of Non Prescribed or Illegal Drugs

Students are not to use, possess, sell, or be under the influence of non-prescribed or illegal drugs, beer, or other intoxicating beverages on the school grounds at anytime or while they are on a school sponsored activity off campus. The use or possession of tobacco on the school grounds is prohibited.

These are matters of state law and cannot be permitted in the school, in the immediate school area, or at school related activities, or on school buses. Student's possession of tobacco, drugs, and/or alcoholic products in school, or at school activities, results in confiscation and discipline. (See also AFFC/ACSB 5131.6, AFFC/ACSB 5131.61, AFFC/ACSB 5144 and/or AFFC/ACSB 5144.1 concerning Substance Abuse, Tobacco and Discipline).

Weapons and Dangerous Instruments

It shall be the policy of the St. Joseph Catholic School Board of Education that weapons and other dangerous objects are taken from students and others who bring them on to the school property or from students who are participating in any school-related activity away from school premises. Parents/guardians of students found in possession of a weapon or dangerous object shall be notified. Confiscation of weapons or dangerous objects will be reported to law enforcement officials and the student will be subject to disciplinary action. Students in possession of a firearm while on school property, or participating in any school-related activity away from school premises shall be expelled for not less than twelve months. Further reference can be found in AFFC/ACSB 5131.7a.

Weapons (both real or toy), guns or knives may never be brought to school. This includes toy guns (including squirt guns) and toy knives. They may never be transported on a bus. This regulation includes plays and skits.

Corporal Punishment, Restraint, and Physical Confinement and Detention

State law forbids school employees from using corporal punishment against any student. Certain actions by school employees are not considered corporal punishment. Additionally, school employees may use "reasonable and necessary force, not designed or intended to cause pain" to do certain things, such as prevent harm to persons or property.

State law also places limits school employees' abilities to restrain or confine and detain any student. The law limits why, how, where, and for how long a school employee may restrain or confine and detain a child. If a child is restrained or confined and detained, the school must maintain documentation and must provide certain types of notice to the child's parent/guardian.

VII. Extracurricular Activities

Activity options

Students have opportunities to participate in:

Music Grades 3-8

- Major Faith Choir (Grades 3-5)
- Middle School Choir (Grades 6-8)
- Beginning Band (Grades 4-5)
- Band (Grades 5-8)
- Jazz Band (Grades 5-8)

Band and choir meet as a class during school hours. Instrumental music and choir require a semester commitment. Permission to be dismissed as a member of any music group must be with mutual agreement of the parents/guardians, the teacher, and the principal.

<u>STEM Club (K-2)</u> is offered once a year for students in grades K-2. This club meets 8 times after school and will take part in STEM related activities with the Kindergarten and 1st grade teachers.

STEM Club (3-5) is offered once a year for students in grades 3-5. This club meets 8 times after school and will take part in STEM related activities with the 4th and 5th grade teachers.

<u>Crazy 8's Math Club</u> is offered once a year to students in grades K-5. This club meets 8 times after school on Wednesdays. This club does hands on experiments revolved around math concepts.

<u>Speech Contest</u> The Metropolitan Catholic Schools sponsor a speech contest each year for 7th and 8th grade students. All students are invited to participate to represent St. Joseph Catholic School.

8th grade Class Trip All 8th graders who meet academic requirements may participate in the 8th grade field trip.

<u>Lego League</u> (Age 9 and up) Students have the opportunity to participate in an after-school program that promotes technology, science, and engineering. Lego League members will work on fun and challenging projects with the help of volunteers from local businesses.

<u>Student Council</u> (Grades 5-8) It is important that each student be represented by the student council. The formation of a student council will be completed during the first few weeks of school. There will be permanent representatives from each homeroom and/or grade. The election of president, vice-president, secretary, and treasurer will be at-large.

Athletics

St. Joseph Catholic School provides organized sports for boys and girls in accordance with the constitution of the IHSSA and IHSGA. Sports are offered when interest level allows a team to be made. The sports include:

Boys: football, basketball and track Girls: volleyball, basketball and track

Students participating in these programs are required to have a physical and a signed statement of fitness by a physician. The physical on file must be current (within 13 months of current date). Students may not participate in practice or games without a current physical. This must be on file with the school. Students who do not perform in accord with their academic requirements or who display consistent behavior problems will be suspended from the team until the necessary improvement is shown.

When a student is absent from school because of illness, he/she may not participate in practice or any scheduled game or activity that day.

The school building and/or gym may not be entered until a coach is present for practice

Sportsmanship - At athletic contests students should treat opponents, spectators and officials with Christian courtesy and respect. Younger students are expected to sit and stay with their parents/guardians during games. We should strive to be known for our good sportsmanship.

Further information regarding our middle school athletic program is provided at the August registration and various other times throughout the year. All students have the opportunity to participate.

Public Conduct on School Premises

School sponsored or approved activities are an important part of the school program and offer students the opportunity to participate in a variety of activities not offered during the regular school day. School sponsored or approved activities are provided for the enjoyment and opportunity for involvement they afford the students.

Spectators will not be allowed to interfere with students participating, other spectators, or with the performance of employees and officials supervising the school sponsored or approved activity. Spectators, like the student participants, are expected to display mature behavior and sportsmanship.

Therefore the following provisions are in effect:

- Abusive, verbal, or physical conduct by spectators directed toward participants, officials, sponsors, or at other spectators will not be tolerated.
- Verbal or physical conduct of spectators that interferes with the performance of students, officials, or sponsors will not be tolerated.
- The use of vulgar, obscene, or demeaning language directed at students, officials, or sponsors participating in a sponsored or approved activity or at other spectators will not be tolerated.

If a spectator at a sponsored or approved activity becomes physically or verbally abusive, uses vulgar, obscene, or demeaning language, or in any way impedes the performance of an activity, the individual in charge of the event may remove the spectator from the event. The administrator may recommend to the board the exclusion of the spectator from future sponsored or approved activities.

Student Activities

We are all identified with St. Joseph Catholic School. What students do outside of school and at school related events *is not in all cases beyond the jurisdiction of the school.*

Use of Facilities

- 1. The facilities shall not be used for any commercial purpose, without the expressed written consent of the Board of Education.
- 2. The gym is never available for any activities on Wednesday afternoon or evening other than for Youth Faith Formation.
 - 3. All school affairs or school-sponsored activities have priority over all other groups.
 - 4. All activities are scheduled through the Principal's Assistant/Athletic Director.
 - 5. The priority of facility use shall be as follows:
 - a. School affairs
 - b. Parish activities
 - c. Catholic school sponsored activities, such as The Saints baseball league
 - d. Other Catholic-related organizations or activities
 - e. Other organizations
- 6. User must provide a certificate of insurance, if it is not a school-sponsored activity. If the user does not have a certificate of insurance, they will be charged the cost of obtaining one.
- 7. The user must have at least one responsible adult present during the period of use. Adults are the first and last in the building or outdoor facility; children are never left alone.
 - 8. No alcoholic beverages may be brought to or consumed in the building or on the grounds.
 - 9. During facility use, participants are to restrict use to the area reserved.
- 10.A responsible adult is to check that outside doors to the building are locked before leaving the facility at conclusion of activity.

Call the school office for the cost of renting for non-school and non-parish sponsored activities.

VIII. Health/Safety Issues

Absence Due to Health

A child must be fever-free twenty four hours before returning to school. A child must also be vomit-free and diarrhea-free for twenty four hours before returning to school. This helps to control the outbreak of illness within the school.

<u>Abuse</u>

In compliance with School Laws of Iowa and AFFC/ACSB 4116.30a any certificated or licensed employee of St. Joseph Catholic School who has a reasonable belief that a child under the age of 18 has been abused by a person responsible for the care of the child, as defined by law, shall report the suspected abuse verbally to Department of Human Services (DHS) within twenty-four hours and follow the verbal report with a written report on appropriate forms.

Employees will not commit acts of physical or sexual abuse, including inappropriate and intentional sexual behavior, toward students.

St. Joseph Catholic School is committed to protecting all students from all types of abuse. If you believe that a student is suffering from any type of abuse, please contact the principal or Kim Hermsen, Superintendent of Schools, so that this can be reported to trained investigators. This policy is in compliance with Iowa Code 280.17, School Rules of Iowa 281-102.1—. 15 (280), AFFC/ACSB 4116.30a & AFFC/ACSB 4116.30b.

Alcohol/Drug Policy

The St. Joseph Catholic School Board develops guidelines that are in accordance with AFFC/ACSB 5144 and AFFC/ACSB 5144.1 on student responsibility and discipline.

<u>Asbestos</u>

Federal regulations and AFFC/ACSB 7113, require us to inform you that there is asbestos in the St. Joseph Catholic School building. A certified asbestos inspector has inspected the building and all the asbestos found has been sealed and encapsulated. The most recent inspection was 2007.

Blood Borne Diseases

Children diagnosed as having any blood borne pathogen disease, or with laboratory evidence of infection with a blood borne pathogen associated virus (HILV-III/LAV) and receiving medical attention may attend classes in a unrestricted educational setting in accordance with AFFC/ACSB 5141.2.

Chemical Right to Know Law

The Chemical Right to Know Law requires that all schools in the nation prepare a list of chemicals that are known to be present in their buildings and to maintain material safety data sheets (MSDS) on them. The law further states that all chemicals are to be appropriately labeled, storage areas are to be posted for the hazardous chemicals, and employees that work with the chemicals are to be trained in the safe handling of these chemicals. The school is also to acquaint the local fire department with the location of hazardous chemicals in the school. If you want to know what chemicals are used in the school and where they are stored please contact the principal.

Fire and Tornado Drills

Unannounced drills are conducted at various times during the year in accordance with Iowa codes. Students are expected to leave in an orderly fashion, without talking, according to the directions of the teacher and return the same way. State law requires two tornado drills and four fire drills each year.

Violent Intruder Drills

Violent intruder drills will take place throughout the school year. Students will be educated and prepared before these occur. Students will be taught the appropriate response to different situations and scenarios.

Food Allergies

Parents are requested to notify the school office, the classroom teacher, and the lunchroom staff if their child has allergies to any food substance (peanuts, milk products, etc.).

Lead in the Drinking Water

During 1991 all schools of the Archdiocese were tested for lead in the drinking water. The test results indicated the lead levels were below the established safety levels. Based upon these results and the rules of the Iowa Department of Public Health no additional testing for lead needs to be done at this time.

Medication

Dispensing of prescription drugs will be administered by a nurse or designated party with training and with the written consent of parent(s). A physician's signed, dated authorization including the name of the student, physician, medication, dosage, and medication schedule must be given to the school on or with the original container. A record of each dose of medication administered will be documented in the pupil's health record. Students utilizing asthma or airway constricting prescription medication are allowed to administer their own dosage provided a completed consent form is on file in the school's office. Contraceptives will not be dispensed.

Dispensing of non-prescription drugs may occur, provided the parents have signed and dated an authorization identifying medication, dosage, and time interval to be administered.

Smoking / Smoke Free Building

St. Joseph Catholic School has been designated a "Smoke Free Building". At no time will smoking be permitted within the building or on school grounds.

Visitors:

Students who request to have a visitor attend school with them should:

- 1. Receive permission from the principal and inform their teachers at least one day in advance.
- 2. On the day of the visit, a pass must be issued and signed by the principal. This pass must be shown to each teacher before class begins and the visitor introduced to the teacher. Teachers have the right to refuse permission to a visitor.
- 3. Students having guests are responsible for that persons conduct. Visitors are expected to abide by all school regulations and conduct themselves properly. Visitors must dress appropriately and in good taste.

IX. Services

Bicycles/Motorized Scooters

Students are permitted to ride bikes to school. Bikes may not be ridden on school grounds or on sidewalks. They are to be walked across the street at the main crossing by the stop sign. Once past the crossing and patrolled area students may begin to ride their bikes. No Bikes/Motorized Scooters are allowed on the school side of the street where buses load and unload.

The school accepts no responsibility for bikes parked on school property. All bike riders bring bikes at their own risk.

Lunch

Lunch is available at the hot lunch program. Students receive a code. Money for daily, weekly, or monthly lunch or milk may be sent to school with your child in an envelope marked Hot Lunch. Parents may send one check for the family and may deposit any amount in your child's lunch account. You will receive an email when your account balance is low.

Menus are posted monthly electronically on the website. Milk is available for students who wish to bring their lunch. The price of the lunch and the price of milk will be published in August.

Free and reduced lunches are available through the program. Applications are welcome anytime during the school year. The codes are the same as all other codes.

Bus

If your child is a bus rider, they will be put on the bus unless we have a note stating otherwise. Transportation is provided by the Linn-Mar and Marion Independent school districts. The phone number for the Marion School District is 377-0123. The phone number for the Linn-Mar School District is 447-3030. Rules established by these agencies are to be followed as though they were rules of St. Joseph Catholic School. A student may be suspended from bus transportation for inappropriate conduct. Transporting students to school requires the cooperation of bus drivers, students, and parents to assure that high safety standards are maintained.

Lockers

Lockers are to be kept clean and orderly. Valuables should not be placed in a student locker. No decals are to be pasted on lockers nor may scotch tape or paste be used for pictures. Masking tape may be used. Lockers are subject to inspection by the administration. Lockers are to be used only by the student to whom they have been assigned. If any damage is incurred during the year, the damage will be charged accordingly. Interior locker decorations must be in good taste representing school values.

Lost and Found

All students need to be taught to be responsible for their personal belongings. An effort is made to find the owners of articles of clothing, lunch boxes, play equipment, etc. There is a box of found articles if parents wish to check it. Periodically, any unclaimed items will be given to the needy.

<u>Textbooks</u>

Textbooks are provided to all students. Undue wear, damage, or loss will require payment at the end of the school year. Books belonging to the school are to be covered at all times. At the end of the school year or upon leaving our school, students must return all textbooks or reimbursement must be given to the school.

Tuition Tax Credits

Expenses incurred by parents may qualify for tuition tax credits as part of their Iowa income tax reporting. Information is distributed annually, usually at the end of the calendar year.

Tuition Grants

Tuition Grants

No one should be denied a Catholic education because of financial need. Grants are available for those families who cannot pay their fees and/or tuition through the *Our Faith School Tuition Organization*. Families can apply for local financial assistance at any time during the school year by contacting the principal or bookkeeper. Applications for the following school year are available through the school office during Catholic Schools Week. Please ask the principal for further information. Confidentiality is maintained. (ACSB Policy #3240.1)

Education Savings Accounts (ESA)

Education Savings Accounts are available from the State of Iowa. Parents who choose to enroll their eligible children in an accredited nonpublic school will receive an amount equal to the per pupil funding allocated to public school districts for the same budget school year. Funds will be deposited into an education savings account (ESA) to be used for tuition, fees, and other qualified education expenses as specified in the legislation.

Students First ESAs will be available based on the following eligibility:

Year 1: School Year 2023-24

- All entering kindergarten students
- All students enrolled in a public school

• A student enrolled in an accredited nonpublic school with a household income at or below 300% of the 2023 Federal Poverty Guidelines, \$90,000 for a family of four

Year 2: School Year 2024-25

- All entering kindergarten students
- All students enrolled in a public school
- A student enrolled in an accredited nonpublic school with a household income at or below 400% of the 2024 Federal Poverty Guidelines that will be updated January 2024

Year 3: School Year 2025-26

• All K-12 students in Iowa regardless of income

Before & After School Program

There is a before and after school program in the building. This program will run before school from 6:30 a.m. to 8:00 a.m. and after school from 2:50 p.m. to 6:00 p.m. Please call the school office at 377-6348 for more information.

School Nutrition Account Policy for St. Joseph Catholic School

It is the policy of St. Joseph Catholic School is to offer nutritious meals to all students who desire them. Parents are notified of low balances via email starting at \$10 and negative balance emails are sent daily via email once balance is \$0.00 or below.

When the balance becomes zero or is negative, the following procedures will apply.

- Students may charge any combination of meals up to a negative balance of \$50.
- No beverage, snack or ala carte items may be charged.
- When the negative \$40 charge limit is reached, lunch personnel will let parents know that their child will be receiving an alternate lunch when negative \$50 has been reached.
- When the negative \$50 charge limit is reached an alternate sandwich and milk will be served for lunch until charges are paid in full. This alternate lunch will not be charged to the student's account.
- If a student with a negative balance attempts to purchase beverage, snack or ala carte items with cash, the money must first be applied to the negative balance.
- Students qualifying for free lunches will always receive one regular meal, even if there is a negative balance from other purchases.
- Students qualifying for reduced lunches will always receive one regular meal, even if there is a negative balance from other purchases or if there are insufficient funds to cover the reduced portion of their meal.
- As a Catholic institution, the school board has made a commitment to reimburse the school nutrition program for the amount of unpaid balances resulting from the unpaid portion of reduced lunches.
- Administration discretion can be used in any situation.

Prayer, Beliefs and Practices

The following Prayers, Beliefs and Practices are found in the Compendium - Catechism of the Catholic Church ©2006 and the United States Catholic Catechism for Adults ©2006. Prayers are organized from the most foundational to more complex; Belief and Practices are alphabetized. The Prayers, Beliefs and Practices have been subdivided into the grades in which it is recommended that they are to be taught. While there is no definitive statement which assigns the Prayers, Beliefs and Practices to the various grade levels, the Prayers, Beliefs and Practices coincide with suggestions and recommendations as presented in "By Their Fruits You Shall Know Them. . ." (NCEA) and Sowing the Seeds of Faith (NCCL) which reflect developmentally-appropriate levels.

Communion Regulations

- As Catholics, we fully participate in the celebration of the Eucharist when we receive Holy Communion. We are encouraged to receive Communion devoutly and frequently.
- In order to be properly disposed to receive Communion, participants should be conscious of no grave sin and normally should have fasted for one hour.
- A person who is conscious of grave sin is not to receive the Body and Blood of the Lord without prior sacramental confession except for a grave reason where there is no opportunity for confession. In this case, the person is to be mindful of the obligation to make an act of perfect contrition, including the intention of confessing as soon as possible (CIC, can. 916).
- A frequent reception of the Sacrament of Penance is encouraged for all.

Communion Fast

• We are expected to fast from food or drink for at least one hour prior to the reception of Holy Communion.

St. Joseph Catholic School Parking Lot Protocol

Dear Parents/Guardians,

As always, child safety is a priority at St. Joseph Catholic School. To ensure that school arrival and dismissal is safe and orderly, we are asking you to be aware of our school arrival and dismissal protocol.

All pick up and drop off of K-8 students will be in the parking lot.

Please observe the following for DROP OFF after 7:30 am:

- 1. Please enter **only** at the Brockman Avenue driveway.
- 2. Please follow the moving lane of traffic from the Brockman Avenue entrance towards the school and out the south 14th Street exit.
- 3. The drop off lane will be continuously moving, with the student drop off area in the large open area by the staff parking lot.
- 4. Please remind your children to walk in front of the car if they are exiting on the driver's side.
- 5. Bicycles are asked to enter from the Brockman Avenue entrance. Bikes must be walked while in the parking lot. Walk bikes to the bike rack area by the football field.

Please observe the following for PICK UP after 2:40 pm:

- 1. Please enter **only** at the Brockman Avenue driveway.
- 2. Pick up in the moving lane of traffic, please follow the moving lane of traffic from the Brockman Avenue entrance towards the school and out the south 14th Street exit.
- 3. The pick up lane will be continuously moving, with the student pick up area in the large open area by the staff parking lot. If you child is not out of the school when you are in the pick up area, we ask that you continue moving and re-enter at the Brockman Avenue entrance.
- 4. Please remind your children to walk in front of the car if they are going to enter on the driver's side.
- 5. Bicycles are asked to exit out the Brockman Avenue entrance. Bikes must be walked while in the parking lot.

Finally, we ask that you be aware that children are not to be on the playground unsupervised before or after school. Children playing on school grounds must be accompanied by a responsible adult.

We appreciate your cooperation in ensuring the safety of all students at St. Joseph Catholic School!

St. Joseph Catholic School - Dress Code

The dress code of St. Joseph strives to reflect good taste, neatness, cleanliness, and Christian modesty while avoiding trends and fads. It is expected that parents/guardians, working with the school, will require their students to leave home dressed in accordance with these regulations. Unless otherwise specified, the Dress Code applies equally to all students. The Administration reserves the right to interpret the Dress Code. Its decisions are final.

<u>Shirts/Blouses</u>: Collared long or short-sleeved dress shirts, polo shirts or turtlenecks, must be worn as the outer garment unless covered by Dress Code compliant sweater or sweatshirt. All shirts/blouses must have sleeves. Shirts/blouses must be tucked in at all times and must be buttoned one button from the top. T-shirts or tank tops with insignias that are visible under the shirt are not allowed. Small logos and/or monograms are permitted on the front of the shirt/blouse only.

Middle School: All 6-8 students must have at least one solid white shirt to be worn on specifically determined days during the school year.

<u>Pants</u>: Shades of tan, navy, black, green or gray solid color ankle length dress pants. No bib overalls and denim is not allowed except on out of uniform days. Corduroy and cargo pants are allowed. Slacks must be worn at the waist.

<u>Shorts</u>: Shades of tan, navy, black, green or gray solid color walking/knee/Bermuda length shorts, Capris may be worn August, September, May and June. In April and October if the weather forecast broadcast on a local television or radio station calls for temperatures above 75 degrees F, students are permitted to wear shorts, Capris or skorts. Cargo shorts are permitted but no boxers, biking shorts, Lycra or nylon athletic shorts.

<u>Dresses and Skirts</u>: Uniform-style jumpers, skirts, and skorts in shades of tan, navy, black, green, or gray solid color are allowed in grades K-5. They must be knee length. Shorts must be worn under jumpers and skirts if leggings or tights are not worn. Tights or leggings must be worn October – April. In April and October if the weather forecast broadcast on a local television or radio station calls for temperatures above 75 degrees F, students are permitted to wear uniform-style jumpers and skirts without tights or leggings. Dresses are allowed only on designated dress up days. They must have sleeves and must be knee length. Students may wear solid color leggings or tights. Leggings must be close to the leg and go to the ankle; they may not: have wide legs or flare at the ankle. Leggings and tights cannot have patterns, emblems, or any design on them and must be the shades of tan, navy, black, gray, or white.

<u>Sweaters/Sweatshirts:</u> Dress sweaters, sweater vests, cardigans and approved St. Joseph or Xavier crewneck or hooded sweatshirts with a dress code shirt underneath are allowed. No other coats, sweatshirts, hooded items, fleece, jackets or vests may be worn inside the classroom during school hours. Small logos and/or monograms are permitted on the front of the dress sweaters, sweater vests, and cardigans. Note: Check with the office for approved sweatshirt.

<u>Head Gear</u>: Hats, caps, bandanas and other head coverings are not permitted during the school day. Headbands cannot have ornaments affixed. (Examples-No cat ears, crowns, hats)

Socks: Socks and tights must be worn with all shoes. Tights must be the shades of tan, navy, black, gray, or white.

<u>Shoes</u>: Leather, canvas, nylon. Shoes must have a fully enclosed heel and closed toe. Ugg style and cowboy boots are allowed. No sandals, clogs, or "croc" style footwear, and no shoes with wheels.

<u>Hair</u>: Neat and well groomed with only natural hair colors, which includes extensions.

Make-up: Conservative make-up is permitted for the 6th, 7th and 8th grades.

<u>Jewelry</u>: Earrings allowed only in the ears. Rule of One-one of each (pair of earrings, necklace, bracelet, & ring) may be worn, but not in multiples.

Scouts & American Heritage Girls: Uniforms may be worn on meeting days or special events.

<u>Out of Uniform Days</u>: On designated out of uniform days, appropriate sweatshirts or t-shirts may be worn. Leggings can be worn, but the shirts worn with them must cover student's buttock. No advertising for alcohol, drugs, bars, etc. Students not participating must be in approved Dress Code attire.

Additional Information:

The Dress Code will be enforced during the regular instructional school day (e.g. 7:45 a.m. to 2:40 p.m. or 7:45 a.m. to 12:40 p.m.) or as otherwise directed by the Administration or for special events.

Acceptable Use Policy (AUP)

Purpose

The purpose of the AUP is to set forth policies and guidelines for St. Joseph Catholic School. The AUP will clarify policies about all electronics and the capabilities that go with the electronics. St. Joseph Catholic School provides students with the opportunity to use computers, iPods and iPads. Along with the technology hardware, St. Joseph Catholic School also provides Internet access and many different software programs to support the hardware, as well as student learning. Computer resources are provided for all students in Grades K-8.

Right to Privacy

System users have no right of privacy and should have no expectation of privacy in

materials sent, received or stored in school-owned computers or on the St. Joseph Catholic School system. School officials reserve the right to review the St. Joseph Catholic School system use at any time to determine if such use meets the criteria set forth in St. Joseph Catholic School Board Policies and Regulations. Routine maintenance and monitoring of the system may lead to the discovery that the user has or is violating the AUP and this regulation, the Code of Conduct or other St. Joseph Catholic School Board Policies and Regulations governing student discipline, or the law. Once an issue arises, an individual search will be conducted when there is reasonable suspicion that the user has violated the law, the Code of Conduct or St. Joseph Catholic School Board Policies or Regulations governing student discipline. The nature of the search/investigation will be reasonable and in keeping with the nature of the alleged misconduct. Employees will not post private information about another person or disclose, use, or disseminate personal information regarding minors without formal authorization. St. Joseph Catholic School provides iPads/iPods/computers and the Internet for educational use.

Student Rules

As a student, I know that I must follow these rules:

- 1. I will only use the Internet and computers with the teacher's permission, and for the purpose that the teacher has requested.
- 2. I will respect copyright laws and will make sure to show where I found information, and will not copy it without permission.
- 3. I will not enter inappropriate or hurtful language into the computer.
- 4. I will stay safe on the Internet by making sure that I never share personal information, such as my full name, address, or telephone number. If anyone on the Internet tries to meet with me, I will refuse and tell my parents or teachers immediately.
- 5. I will let my teacher know immediately if I see anything on the Internet that is inappropriate or that makes me uncomfortable.
- 6. I will respect the school computer equipment. I will be sure to take good care of the equipment I use, and will not change any desktops, controls, or anyone else's files.
- 7. I will only use my own passwords that have been given to me by the teacher.
- 8. I will not put any disks or CDs into the computer unless they are approved by the teacher
- 9. I will only use email for a class project directed by my teacher. Any mail will be sent or received by my teacher.
- 10. I will only download information onto school computers under the direction of my teacher.
- 11. I will not buy or sell anything using the school computers.
- 12. I understand that I will be able to use school computers only if I follow these rules.

ATTENDANCE:

Regular attendance is an integral part of responsibility. Absenteeism inhibits the quality of a student's school experience and education. If the student is absent from class, he/she misses the interaction and discussion that occurs. While written assignments can be made up, the class participation can never be replaced. Therefore, it is expected that students will be in attendance each and every day school is in session. Extended absences are discouraged unless justified (e.g.- serious illness).

The Iowa Compulsory Education Law (Iowa Code 299.1) states: "Children in Iowa are required to attend school between the ages of 6 and 16 by September 15th of each year. If a child is at least 4 by September 15th and enrolled in a statewide preschool program, the attendance rules apply to the child." This law specifies procedures for dealing with attendance concerns.

<u>Archdiocesan Policy 5144.2</u> states: The Archdiocesan Catholic School Board requires 148 days annually, to be met by attendance for at least 37 days per quarter.

- 1. Teachers/Administrators monitor student attendance and make a referral to the building principal after the 7th absence during the semester. The student's attendance record is reviewed.
- 2. After review of the attendance records, the parent/guardian will be notified. Documentation of the notification will be placed in the student's cumulative folder.
- 3. If warranted, a home visit is made after the 7th absence in a school year. This visit is made by appropriate school, parish, and/or community personnel.
- 4. The <u>Home Visit Report</u> will be completed. After review by the principal, the report is placed in the student's cumulative folder and a copy sent to the parent/guardian.
- 5. Following the 15th day of absence in a school year and a review of the student's attendance record is conducted by the local school administration. As per policy 299.1 of the Iowa Code the County Attorney's office will also be notified.
- 6. All points detailed above are subject to administrative discretion on a case-by-case basis.

Archdiocesan Board Policy 5144.2, Archdiocese of Dubuque

> Iowa Code 299.1 State of Iowa

Archdiocesan Policy 5144.2:

"Each local school shall have a specified procedure for dealing with attendance concerns, consistent with Iowa Code 299.1 The Archdiocesan Board of Education requires 148 days annually, to be met by attendance for at least 37 days per quarter."

Iowa Code 299.1:

299.1 Attendance requirements.

Except as provided in section 299.2, the parent, guardian, or legal or actual custodian of a child who is of compulsory attendance age, shall cause the child to attend some public school, an accredited nonpublic school, or competent private instruction in accordance with the provisions of chapter 299A, during a school year, as defined under section 279.10. The board of directors of a public school district or the governing body of an accredited nonpublic school shall set the number of days of required attendance for the schools under its control.

The board of directors of a public or the governing body of an accredited nonpublic school may, by resolution, require attendance for the entire time when the schools are in session in any school year and adopt a policy or rules relating to the reasons considered to be valid or acceptable excuses for absence from school.

299.1A Compulsory attendance age.

A child who has reached the age of six and is under sixteen years of age by September 15 is of compulsory attendance age. 91 Acts, ch 200, §4

Tardy/Half Day Absences

Students are considered tardy if they are not in their classroom at 7:45 am. Students are considered absent for a half-day if they miss more than 1.5 hours of school.

Procedures for Absences

The school office is to be notified of an absence by 8:30 a.m. the day of the absence.

Pre-planned Absences:

If the student/parent knows beforehand that the student will not be in attendance on a given day (or days) you should notify the Main Office and the teachers to arrange make-up work. For an absence of two or more days, at least one week's advance notice is recommended. A note, phone call, or email is required for a student to be dismissed early. The parent/guardian must come into the office to sign out the student. No child is released unless the Administrator or Administrative Assistant knows the reason for the early release and whom the child will be released. The school accepts no responsibility for any child who leaves school without the proper permission.

Illness during the school day:

Students who become ill during school need to be picked up from school within 30 minutes. Students must be free from fever, vomiting and diarrhea for 24 hours before returning to school.
